is in the best interests for the education of all students located within those Districts to unite into one new District; and,

WHEREAS, pursuant to the Commissioner's October 23, 2018 order, the Elizabethtown-Lewis Central School District and the Westport Central School District were thereby laid out as the Elizabethtown-Lewis-Westport Central School District ("District"): and

WHEREAS, the District's Board of Education seeks to adopt a new simplified name for the District in accordance with the Education Law and Commissioner's regulations:

# BE IT RESOLVED THAT THE BOARD OF EDUCATION NOW HEREBY:

- 1) Adopts the following simplified name for the District: Boquet Valley Central School District
- 2) Authorizes a certified copy of this resolution to be submitted to the Commissioner of Education for approval including seeking a formal certificate setting forth the approved legal name approved by the Commissioner.
- 3) Authorizes any further action be taken consistent with this resolution and the intent herein.

- Scheduling offering electives, pursuing Advanced Placement courses, etc.
- Providing continued professional development for all staff

Mr. Meyer thanked electrician Ryan Hathaway and the CV-TEC students working under his advisement for installing wiring throughout the Elizabethtown-Lewis building in preparation for technology upgrades that will be forthcoming. Recommendations that will be presented to the Board will include:
