This is a challenge for rural school districts. We have about 95% of our teachers with some kind of internet access at home. The remaining 5% is making use of hotspots.

Our Director of Student Support Services, in collaboration with the guidance counselors, psychologist, special education teachers, teaching assistants, and aides, have set up a system of regular communication and use of certain technologies to do their best to meet all unique needs of students including telehealth therapy.

For our unique learners (SWD) our Director of Student Support Services in collaboration with our professional staff, school counselors, psychologist, special education teachers, teacher assistants, and classroom aides are working remotely with classroom teachers, students, and families to ensure our curriculum, materials, and activities are accessible to all learners. Professional staff, service providers, and special education teachers are providing therapies, accommodations, modifications, and supports remotely to meet individual needs in accordance with IEPs. The individualized needs are being met using multiple platforms which include teletherapy, videos, google meets, zoom meets, emails, phone calls, and audio recordings. Currently our district does not have any homeless students. Our counselors and teachers are to report any suspicions of homelessness to our principals for further investigation. We are also working with the community based organizations to help identify any potentially homeless students.

11. What tools/strategies are you using to address the social-emotional needs of students, families, and staff during this crisis?

Our counselors, case managers, and AIS teachers are reaching out to these students and families regularly. This service is being advertised in our multiple forms of weekly communications. The staff is meeting regularly to address these concerns.

Essex County Mental Health and Families First (a separate county based organization) are working with individual students and families to address concerns

Some communication is happening daily, others weekly, and others biweekly based on individual circumstances.

The support is happening by way of the remote counseling sessions.

The staff has weekly faculty meetings with an administrator where everyone has the opportunity to check in. The administrators are following up with staff who may need more support.
