

COVID-19 PREVENTION STRATEGIES AND 2020-21 REOPENING PLAN

MASKS AND PERSONAL PROTECTIVE EQUIPMENT

- Masks are required for employees and students when physical distancing is not possible and in any common area.
- Masks are recommended at all times.
- Mask breaks will be scheduled by the classroom teacher.
- Additional PPE will be available when appropriate

WELLNESS AND HYGINE

- Hand-washing and Hand-sanitizing are encouraged throughout the day.
- Physical Barriers installed in select locations throughout the district.

HEALTH AND TEMPERATURE SCREENING

- Parents must perform a health and temperature screening for each child before sending them to school each morning.
- Employees must complete screening and temperature check before coming to work each morning.

HEALTH SERVICES

- All persons who are sick are expected to stay at home.
- Those who become sick at school or work will be sent home immediately.
- Both schools will have a room to isolate symptomatic persons

PUBLIC HEALTH SIGNAGE

- CDC-designed signage displayed prominently throughout the building to reinforce healthy hygiene and expected school and workplace behaviors
- Health information posted on how to prevent the spread of COVID-19
- "Stay at Home if Sick" notices
- Health Screening Signs on entrances

ENHANCED CLEANING

- Improved routine cleaning and disinfecting of facilities by custodians
- Safe and effective cleaner provided to teachers and office staff to use on high-touch surfaces throughout the day.

SCHOOL LOGISTICS

- Physically distance desks in classrooms
- Limit distribution and use of lockers
- Restrict parent access and visitor access to buildings
- Limit number of persons in hallway and other common areas at any one time.

TECHNOLOGY AND CONNECTIVITY

- Contact the building principal with technology and connectivity issues

STUDENT MEALS

- All students will be provided with a free breakfast and free lunch each day.
- Cash will not be accepted for a la carte items. Monies can be added to the student account on-line.
- Remote Learners/Hybrid Learners will have meals available.

TRANSPORTATION

- Parents are asked to consider transporting their children to and/or from school whenever possible to allow for more physical distancing on the school buses.
- All drivers and student will wear a mask on the bus at all times.
- Safe and effective cleaner provided for high-touch surfaces after each run.
- Buses disinfected after each morning and afternoon route.

ATTENDANCE AND PARTICIPATION

- Teachers will take regular daily attendance for both in person and remote learning.
- Communication with parents will include Robo calls, phone calls from school personnel
- Participation is mandatory for course credit

TEACHING AND LEARNING

- Parents will submit a [request](#) for: all in-person, all remote, or a hybrid model using the appropriate form (due August 15th).
- All students must have the opportunity to feel safe, engaged, and excited about their learning.
- Through proper training, students, teachers and staff will be able to transition smoothly throughout the 3 models as we need to adjust for an increase or decrease in COVID -19 cases.
- Maintaining rigor and accountability is a priority for the BVCSD.

SCHOOL SCHEDULE

- Both Campuses have developed schedules that are suited for their age-groups. While the objective is to eventually return all students to in-person instruction, we need to slowly move toward that target.
- This will be evaluated every 5 weeks, and may need to abruptly changed based on COVID cases in the district or in the region.
