To the Families of the Boquet Valley Central School District:

Last week, the governor made an announcement to close schools for an additional two weeks beyond that of April 1st, (which was his initial closure). Please see the language below, then allow me to explain how that will affect Boquet alley Central School District.

The Governor ordered all schools to remain closed for an additional two weeks, extending his prior closure order until April 15. Continued closure will be evaluated at that time. Provided that no school remain closed beyond April 15 without being directed to do so by Executive Order, they will not be penalized for failure to meet the 180 session day requirement. School districts must continue plans for alternative instructional options, distribution and availability of meals, and child care, with an emphasis on serving children of essential workers, and continue to first use any vacation or snow days remaining.

A school closure by the governor supersedes our local decision to close until April 20th. There is certainly the possibility that the Governor will elect to close the schools for additional time as April 15th approaches. This will not affect our 180 day requirement for New York State schools, but we must use our vacation days and emergency days prior to April 15th. An adjusted calendar is listed below for you.

The language also states that we must provide for meals and **"alternative instruction options"** throughout the closure, including over the vacation and emergency days. We will continue to provide food over the new April Break and Emergency Days. We will also continue to provide opportunities for instruction during this time. Teachers are preparing those assignments now and those will be available by the end of this week. I have already heard from some students who are displeased with this decision, considering it additional school days or additional work. I would like to clarify that this is a directive from the Governor. I am not in a position to overrule or ignore these directives. This is an opportunity to ensure that students are moving through the curriculum.
