Pursuant to Executive Order 202.26, the budget vote and election of Board of Education members of the Boquet Valley Central School District, County of Essex, New York, was conducted by an absentee ballot process in lieu of in-person voting. Therefore, there was no voting at the polls for this year's annual budget vote and election due to the prevalence of the COVID-19 virus and potential for spread through personal interaction. Absentee ballots with postage paid return envelopes were sent to qualified voters. In order to be counted, absentee ballots were received in the office of the clerk by 5:00 PM on June 9, 2020.

Executive Order 202.39 modifies the extent necessary to allow any absentee ballot for an election held on June 9, 2020 and received by mail in the office of the clerk of the school district or designee of the trustees or school board not later than June 16, 2020 to be canvassed for such election. No ballots for such election shall be accepted by the clerk of the school district or designee of the trustees or school board after 5:00 PM on June 9, 2020 except those received by mail in accordance with this provision. Any receptacle used for hand delivery of absentee ballots in such election shall be closed and removed at 5:00 PM on June 9, 2020; the ballots therein shall remain unopened pending delivery of mailed ballots, and shall be removed and canvassed after 5:00 PM on June 16, 2020.

Thus, every qualified voter was provided an absentee ballot for the purpose of voting on: (1) the proposed Boquet Valley Central School District Budget for the 2020-2021 school year as approved by the Board of Education, (2) to elect two members to the Board of Education for three terms commencing July 1, 2020 and expiring on June 30, 2023, (3) to authorize and expend \$6,300 from the existing Transportation and Maintenance Equipment Capital Reserve Fund established by a proposition approved by the qualified voters of the Westport Central School District for the purpose of purchasing one salt/sand spreader at a maximum cost of \$2,100, and one aluminum trailer at a maximum cost of \$4,200, for a total aggregate maximum cost of \$6,300, and (4) to authorize and expend \$139,000 from the existing Transportation and Maintenance Equipment Capital Reserve Fund established by a proposition approved by the qualified voters of the Elizabethtown-Lewis Central School District for the purpose of purchasing one 65 passenger school bus at a maximum cost of \$111,000, and a passenger van at a maximum cost of \$28,000, for a total aggregate maximum cost of \$139,000.

At 5:00 PM, prevailing time, the Chairperson announced that all absentee ballots to be counted had been received in the office of the clerk.

Inspectors Marcella Denton, Brenda Drummond, Gwen Goff and Shari Morris, and Chairperson Jana Atwell immediately began the process of opening, shuffling, sorting (color coded by proposition) and counting the ballots.
